

## **Terms and Conditions – Fuel Gift Card Promotion (10% Cashback Offer) (Australia)**

### **1. Promotion Overview**

This promotion offers eligible customers a 10% cashback on the purchase of Shell Fuel Gift Cards, subject to these Terms and Conditions and applicable Australian laws, including the *Competition and Consumer Act 2010 (Cth)* and the Australian Consumer Law (ACL).

### **2. Promoter**

The promoter is PS Rewards Pty Ltd ABN: 56 675 184 460 of 197 St Georges Terrace, Perth WA 6000 (“Promoter”).

### **3. Eligibility**

- Entry is open to Australian residents aged 18 years or over.
- The promotion is limited to retail customers only and excludes wholesale or commercial purchasers.
- Directors, management, employees, and contractors of the Promoter and associated entities may be ineligible to participate.

### **4. Promotion Period**

- The promotion commences on 20.04.2026 at 1pm AWST and ends on the earlier of:
  - (a) 23.04.2026 at 1pm AWST or
  - (b) when the total qualifying gift card sales reach \$25,000 (Promotion Cap).

### **5. Cashback Offer**

- Eligible customers will receive a cashback equal to 5% of the purchase price of a Shell Fuel Gift Card.
- Cashback will be calculated on the amount paid at checkout, excluding any fees or charges.
- Cashback will be provided via the PS Rewards Pty Ltd application to registered users within 5 minutes of a valid purchase.
- Cashback is not transferable or exchangeable and cannot be redeemed for cash other than as specified in these Terms.

### **6. Promotion Cap**

- The cashback offer is strictly limited to the first \$25,000 in total gift card sales during the Promotion Period.
- Once this limit is reached, the promotion will cease immediately. Purchases made after this point will not be eligible for cashback, even if processed shortly thereafter.

### **7. Purchase Limit**

- Strictly limited to one (1) gift card per customer for the purpose of this promotion.
- The Promoter reserves the right to verify customer identity and refuse or cancel transactions suspected of circumventing this limit.

### **8. Availability**

- Gift cards are subject to availability and may sell out prior to the end of the Promotion Period or before the Promotion Cap is reached.

#### **9. Australian Consumer Law**

- Nothing in these Terms and Conditions excludes, restricts, or modifies any consumer guarantees, rights, or remedies available under the Australian Consumer Law.
- Gift cards and any associated services come with guarantees that cannot be excluded under the ACL. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage.
- If a failure with the gift card does not amount to a major failure, you are entitled to have the failure rectified within a reasonable time.

#### **10. Refunds and Returns**

- Refunds for gift card purchases will be provided in accordance with the ACL.
- If a refund is issued, any associated cashback may be reversed or deducted from the refund amount where permitted by law.

#### **11. Misuse and Fraud**

- The Promoter reserves the right to disqualify any customer who tampers with the promotion, engages in fraudulent conduct, or breaches these Terms and Conditions.
- This includes attempts to exceed the one-per-customer limit through multiple accounts, identities, or payment methods.

#### **12. Liability**

- To the extent permitted by law, the Promoter is not liable for any loss, damage, or injury suffered as a result of participating in the promotion or using the gift card, except where such liability cannot be excluded under the ACL.
- Where liability cannot be excluded, it is limited to the minimum extent permitted by law.

#### **13. Privacy**

- Any personal information collected as part of this promotion will be handled in accordance with the Promoter's Privacy Policy and the *Privacy Act 1988 (Cth)*.

#### **14. Changes to Promotion**

- The Promoter reserves the right to amend, suspend, or cancel the promotion at any time, subject to applicable laws and regulatory approvals where required.

#### **15. Governing Law**

- These Terms and Conditions are governed by the laws of Western Australia and the Commonwealth of Australia. Participants submit to the non-exclusive jurisdiction of the courts of Western Australia.

#### **16. Acceptance of Terms**

- By participating in this promotion, customers are deemed to have accepted these Terms and Conditions.
